The **Highland Presbyterian Church Nursery and Weekday School** offers a half-day program (8:45 - 11:45 a.m.) with extended and early play options that serves children from infancy through kindergarten. Additionally, we offer a full-day option for kindergarten (8:45 a.m. - 3:00 p.m.). We have a long-standing history of providing high quality early care and education and have a wide menu of options from which you may choose. We hope that you will find an option that matches your family's needs. *Please indicate your preferences on the attached sheet by putting a 1, 2, 3 or 4 by the options for your child's age group.*

When building our classes, we use your child's age as of August 1 to determine class placement. Enrollment will be based on the following priorities: 1) children of current Church members and faculty; 2) children currently enrolled; 3) siblings of currently enrolled children; 4) children previously enrolled, and/or their siblings; 5) children whose parents/guardians attended Highland Presbyterian Weekday School or Parents' Day Out as a child; 6) new students who will be admitted with consideration given to the educational needs of the classrooms, cultural diversity, and date of application.

Please return a separate application for each child at your earliest convenience. **The deadline is January 15, 2024**, to be considered in our first round of placements. After the initial enrollment period, we will consider applications and continue to place children on a rolling basis where space is available. We will notify you if we have a classroom placement available for your child. Please be aware that we require all children to have on file with the school an unexpired Kentucky Immunization Certificate indicating that each child is current for all immunizations.

In lieu of a registration fee, we will collect 10% of the tuition as a non-refundable deposit if we are able to offer an enrollment placement for your child.
