Dear Parents/Guardians,

The **Highland Presbyterian Church Nursery and Weekday School** offers a half-day program (8:45 – 11:45 a.m.) with extended and early play options that serves children from infancy through kindergarten. Additionally, we offer a full-day option for kindergarten (8:45 a.m. – 3:00 p.m.). We have a long-standing history of providing high-quality early care and education and have a wide menu of options from which you may choose. We hope that you will find an option that matches your family's needs. ***Please indicate your preferences on the attached sheet by putting a 1, 2, 3 or 4 by the options for your child's age group.***

When building our classes, we use your child's age as of August 1 to determine class placement. Enrollment will be based on the following priorities: 1) children of current members of Highland Presbyterian Church and faculty; 2) children currently enrolled; 3) siblings of currently enrolled children; 4) children previously enrolled, and/or their siblings; 5) children whose parents/guardians attended Highland Presbyterian Weekday School or Parents' Day Out as a child; 6) new students who will be admitted with consideration given to the educational needs of the classrooms, cultural diversity, and date of application.

Please return a separate application for each child at your earliest convenience. ***The deadline is January 15, 2027*** to be considered in our first round of placements. After the initial enrollment period, we will consider applications and continue to place children on a rolling basis where space is available. We will notify you if we have a classroom placement available for your child. *Please be aware that we require all children to have on file with the school an unexpired Kentucky Immunization Certificate indicating that each child is current for all immunizations.*

In lieu of a registration fee, we will collect 10% of the tuition as a *non-refundable* deposit if we are able to offer an enrollment placement for your child.

- ☐ **PRESCHOOL:** These classes for children ages 2, 3 or 4 play and learn with a consistent group which meets a designated number of days each week. Each class will be led by experienced, professional teachers who observe growth and development, develop a curriculum designed for both the group and individual children, and share with parents/guardians the information gathered in a developmental portfolio at conferences two times each year.
- ☐ **KINDERGARTEN:** Kindergarten offers a child-centered, creative environment where children are encouraged to think, theorize and wonder as they learn. A combination of traditional learning and child-initiated discovery, our Kindergarten has options for half-day and full-day classes.
